# Remembering ... Glynn Spelliscy

#### Remembering Robert Glynn Spelliscy, FCMA. 1914-2012

**Glynn Spelliscy** joined FEI in 1969 and served as President of the Vancouver Chapter in 1975/76. During his long, active life he worked for Canada Safeway, served in the Canadian army in World War 2, and demonstrated a commitment to community involvement for which he received recognition and many awards. These included the Queen's Golden Jubilee Medal, the Magill Lifetime Achievement Award of the CNIB and honorary chief of the Sarcee Nation.

He qualified as a CMA (RIA) in 1948, became a FMCA in 1979 and served CMABC and CMA Canada as a member of committees and boards, and as president.

A highlight of the 60th Anniversary celebration for FEI Canada, Vancouver Chapter in May, 2012 was the recognition of past presidents. Glynn was there with his daughter, Sheila, and had a great time connecting with his FEI friends.

Glynn maintained that "there's no use sitting on the sidelines" and, at the time of his death on October 26, was working with the Vancouver Lions Club to start a breakfast program for children at an Inner City school in Vancouver.
